

STUDENT REGISTRATION

To be enrolled as a student at EBCS, a person should have at least the equivalent of a high school education or have demonstrated their ability to complete and benefit from our courses. Prospective students may register for admission to EBCS by following the instructions outlined in this catalog.

FIRST TIME FRESHMAN

Applicants who have completed less than 12 hours of college credit are considered "First-time Freshmen."

• TRANSFER STUDENTS

Applicants with prior college credit are considered transfer students.

ADMISSION POLICIES

Admission to EBCS is based on academic achievement, demonstrated potential for success in higher education, strong moral character, and a commitment to positively impacting the community or field of study.

EBCS operates on a rolling admission policy, meaning applications are reviewed, and decisions are made on a constant basis as they are received, rather than waiting for a specific deadline. This approach allows applicants to receive admissions decisions promptly, often within a few weeks of submitting all required credentials. Once all materials have been received, the applicant will be notified by email, mail, and/or phone. Admission requirements are subject to change.

ADMISSION

To start the process for enrollment in EBCS the following items must be submitted:

- Application along with a \$50 application fee.
- Photo ID.
- Recommendation letter from a pastor or spiritual mentor/leader.
- Recommendation from a friend.
- Previous school diploma and/or transcripts.
- Student Statement of Faith form.

ADMISSION STATUS

Upon receiving all application materials (application, fees, transcripts, etc.), the application will be reviewed. Notification of admission will be communicated via email within 3-5 business days.

- An application and student statement of faith form must be completed and submitted with the nonrefundable application fee.
- All admissions are subject to final approval by the EBCS enrollment director.

APPLICATION

Prospective students must submit a completely filled-out application form to initiate the admission process. This form must be accurately completed, signed, and submitted in accordance with the guidelines set forth by our institution. PROGRAM ENROLLMENT OPTIONS

EBCS offers three enrollment programs:

HYBRID TRACK

This degree program is offered in a hybrid format, combining campus and online learning. Classes convene one weekend each month, providing students with the opportunity for in-person interaction and collaborative learning. Following each class session, students will have a designated period to complete homework assignments, ensuring ample time to fully grasp the material and prepare for the next class. This structure aims to balance the demands of academic work with the flexibility needed for busy schedules.

FAST-TRACK

The FastTrack program presents an exciting opportunity for individuals who apply and meet the specified requirements. Participants in this program can enroll in up to three classes each month, facilitating an engaging and dynamic learning experience. Classes are thoughtfully scheduled for meeting one weekend each month, allowing students to immerse themselves in face-to-face interactions and collaborative learning with peers. Each class session is designed to impart knowledge, foster relationships, and encourage lively student discussions. Following each session, a structured period is allocated for homework assignments. This dedicated time is crucial, as it empowers students to digest the course material thoroughly, reflect on their learning, and prepare effectively for what lies ahead in the subsequent classes. The FastTrack module is specifically designed for students seeking an accelerated degree path. This program facilitates a quicker route to graduation by allowing participants to streamline their coursework and academic requirements. Currently, the FastTrack option is exclusively available for students pursuing Master's and Doctoral degrees, enabling them to achieve their educational goals more efficiently.

CORRESPONDENCE TRACK

The correspondence program provides a flexible and self-directed learning experience. This allows students to customize their educational journey to fit their needs and schedules. Participants can choose which courses they wish to enroll in, enabling them to focus on subjects that interest them or align with their career goals. Also, students can determine their own pace for completing assignments and progressing through the material, ensuring they have ample time to fully grasp each concept. This program is designed for those who thrive in an independent learning environment and require the ability to balance their studies with other commitments, ultimately leading to the completion of their degree on their terms.

TRANSFER CREDIT REQUESTS

EBCS has established specific guidelines for the transfer of academic credits to ensure a fair and thorough evaluation process:

- Submission of Official Transcript: Students requesting the transfer of credits must submit an official transcript from the institution(s) where the courses were completed. This document must reflect all completed coursework and final grades.
- Comprehensive Course Evaluation: Each course proposed for transfer will undergo a detailed evaluation. This evaluation will carefully compare several factors, including the course's nature, the content covered, and the level of learning experienced. This process ensures that the transferred courses align closely with EBCS's curriculum standards.
- Minimum Academic Standards: To be eligible for credit transfer, the courses must have been
 completed with a minimum grade point average of 2.0. Also, students must have earned a letter
 grade of "C" or higher in each course being submitted for transfer consideration.
- Notification of Transfer Status: Once the official transcript(s) has been thoroughly reviewed, the student will receive a notification regarding the outcome of their transfer credit request. This notification will provide details about which credits were accepted and any further steps that may be required.

LIFE EXPERIENCE CREDITS

Applicants are required to submit a comprehensive life experience portfolio. This portfolio should include a detailed curriculum vitae that outlines their professional and academic achievements and letters of recommendation from credible sources who can attest to their experience and contributions.

TUITION/FEES PAYMENT POLICY

PAYMENT POLICY

- Application Fees are due upon application. Applications submitted without the appropriate application fee will not be processed until the fee is paid.
- Tuition is due before the commencement of classwork. Students who choose to pay tuition in monthly installments must make their first payment before beginning coursework. Subsequent installments will be billed on the first day of each month until the balance is paid in full.

•

• Monthly installments are due regardless of the progress a student makes in any particular month. A late fee of \$20.00 per month will be assessed on the 15th day of each month for any unpaid installment. If a student's account becomes more than 60 days past due, a final notice will be issued. If the account balance is not brought current before the 90th day, the student's account will be closed. The amount due prior to account closure will include (i) any outstanding balance before closure and (ii) unpaid tuition in the amount of \$1,600.00, less than the sum of monthly payments made prior to closure. Student accounts closed due to payment default may be reinstated by paying the full outstanding amount.

EBCS offers several plans to pay for their education. All plans are interest-free:

- Pay in three monthly installments (5% discount)
- Pay over several months

TRANSCRIPT REQUEST

Students wishing to obtain an official transcript or an unofficial course record from EBCS must complete a Transcript Request Form. This form serves as a formal request for their academic records. Also, it is important to include the appropriate fees associated with the requested copies. Ensuring that all necessary information and payments are submitted will help expedite the processing of the request. To ensure the privacy of student information, the request must be in writing and be signed by the student.

REFUND POLICY

If you choose to drop or withdraw from a course after you have registered and/or been admitted to EBCS, it is essential to follow the proper procedures to ensure that you can receive a refund. This process begins

with completing the appropriate forms, typically available at the Registrar's office. Once you have filled out the forms, you must seek approval from the Registrar.

Students are entitled to a refund if they officially withdraw from the enrolled EBCS academic program. The withdrawal request must be submitted in writing, and the official withdrawal date will be determined based on when EBCS receives the written request. Accordingly, the refund amount for tuition will be calculated based on that date. Enrollment fees are non-refundable beyond the required three working days for notification. Payment refunds will be issued according to the following criteria:

- 80% up to the end of 10 days
- 60% up to the end of 15 days
- 40% up to the end of 20 days
- 20% up to the end of 30 days
- No refund after 30 days

**Please note that there is a deadline for changing your enrollment status. You can drop or change courses up to one week before the class is set to start. If you wait until after this deadline to drop a course, you will not be eligible for any refund; in this case, you will lose all funds that could have been refunded. It is advisable to be aware of these deadlines and procedures to avoid financial loss.

FINANCIAL AID AND SCHOLARSHIPS

EBCS offers scholarships to eligible students. The student may apply for scholarships by submitting an application form by the scholarship deadline. Any scholarship awarded will be applied directly to the tuition balance, and the remaining amount will be the responsibility of the student.

Work Study

EBCS offers a generous 40% discount to a select number of work-study students who are enrolled
full-time in either a bachelor's or master's degree program. To qualify, students must maintain
their status as full-time learners while participating in the work-study program. This initiative is
designed to support students in managing their educational expenses while gaining valuable work

Family

- EBCS offers a generous family discount of 45% for families enrolling in the same semester. This

GRADE POINT AVERAGE

A specific grade point average (GPA) must be maintained to earn a degree. Grade point averages are computed by adding the grade points for each grade and dividing the result by the total number of courses taken.

WITHDRAWAL

Students who wish to withdraw from EBCS should submit a written request to the Administrative Office at ebcsok@org. Please review the refund policy regarding financial responsibilities and the withdraw policy.

TERMINATION

EBCS maintains the right to terminate a student's enrollment under the following circumstances:

- Academic Performance: A student may face termination if they receive failing grades (typically
 defined as a grade of "F" or its equivalent) in more than 25% of their assigned coursework. This
 policy aims to ensure students meet the academic standards necessary for their educational
 development.
- Attendance Requirements: Students are required to attend at least 75% of all scheduled lectures
 and classes. Failing to meet this attendance threshold may lead to enrollment termination, as
 consistent class participation is crucial for successful learning outcomes.
- Financial Responsibilities: Students must remain current on all tuition and fees. Those who are delinquent, meaning they have outstanding balances or have failed to fulfill payment agreements, may be subject to termination of their enrollment.

- *Tardiness Policy*: Excessive tardiness, defined as repeated late arrivals to class, can also be grounds for termination. Promptness is essential for maintaining a productive learning environment.
- Behavioral Conduct: Students are expected to conduct themselves in a manner that aligns with EBCS's philosophy and goals, both inside and outside the classroom. Any behavior that is disruptive, disrespectful, or inconsistent with EBCS's values may lead to disciplinary action, including the possibility of enrollment termination.
- Plagiarism: Students are expected to cite all sources used in their academic work according to the
 appropriate style guide. Any instance of plagiarism will be considered a violation of EBCS's
 academic integrity policy and may result in disciplinary action, including a failing grade on the
 assignment, a failing grade in the course, or other consequences as determined by the faculty and
 administration. Plagiarism is the act of using another person's work, ideas, or words without
 proper acknowledgment, including copying text directly from a source, paraphrasing without
 citation, or submitting work obtained from another student or online source without proper
 attribution.

This detailed policy is in place to promote a conducive learning atmosphere and ensure the integrity of the academic community.

If a student has personal or financial difficulties, or if a problem develops concerning any aspect of EBCS, the student should consult with the academic dean immediately. Difficulties should not be allowed to grow until they become insurmountable. The EBCS faculty is prepared to do everything possible to prepare the student for success.

GRADUATION

All degrees conferred by EBCS, located in Oklahoma City, Oklahoma, adhere to the following comprehensive graduation requirements:

To be eligible for graduation, a student must fulfill the following criteria:

To initiate the graduation process, students are required to complete a graduation application. This involves filling out the necessary forms and paying the corresponding graduation fees, which vary depending on the level of degree being pursued. For detailed information regarding the specific fee amount, students should refer to the tuition and fee schedule provided by EBCS. Make sure to adhere to any deadlines to ensure a smooth graduation process.

- Completion of Required Courses: The student must successfully complete all required courses pertinent to the degree they are pursuing. This includes both the core courses and any electives that are necessary for the degree program.
- Credit Hour Requirements: It is essential that the student earns the designated number of credit hours required for the specific degree they are seeking. The minimum credit hours required are:

Bachelor's degrees require at least 120 credit hours Master's degrees require at least 45 credit hours

Doctor's degrees require at least 50 credit hours

Each academic program has its own credit hour threshold, so students should refer to their program guidelines.

- Assignment Completion: All assignments must be completed and submitted with a passing grade

- Field Assignments: Any field assignments that are stipulated by the course syllabus must be satisfactorily completed. These assignments may include practical experiences related to the subject matter, and successful completion is crucial for demonstrating the application of knowledge.
- Financial Obligations: All required tuition and fees must be paid in full before graduation. This includes ensuring that there are no outstanding balances that could affect the student's eligibility.
- Graduation Fee: It is important to note that a graduation fee is applicable. The fee is set at \$150.00 for undergraduate students and \$300.00 for graduate students. The release of final transcripts and diplomas will be contingent upon the payment of the graduation fee, ensuring that all financial obligations are met before receiving these important documents.

Along with the application, a nonrefundable fee of \$75.00 is required. Also, candidates must meet specific criteria to be accepted into the minister's program. Please refer to the following requirements.

- Application along with a \$75 application fee
- Photo ID.
- Recommendation letter from a pastor or spiritual mentor/leader.
- Recommendation from a friend.
- Submit a character letter from a pastor, mentor, or family member.
- Must have at least 3 years of ministry experience
- You must be a born-again believer
- Agree with the EBCS and EEACAB Statement of Faith forms.

MINISTERIAL LICENSE

To qualify for a ministerial license, individuals must enroll in and successfully complete a minimum of 15 class units with EEACAB. This program is designed to provide the necessary knowledge and skills essential for effective ministry.

ORDINATION

To qualify for ordination, individuals must enroll in and successfully complete a minimum of 30 class units with EEACAB. This program is designed to provide the necessary knowledge and skills essential for effective ministry.

BISHOPRIC

To be appointed as a bishop in the Lord's Church, candidates must fulfill several key requirements.

- You must enroll in EEACAB and successfully complete a total of 45 academic units. This
 coursework is designed to provide the necessary theological and practical knowledge
 essential for church leadership.
- You will need to participate in a twelve-month internship. This internship offers hands-on experience in a church setting, allowing you to apply your learning in real-world situations and develop your pastoral skills.
- You must pass the Bishop's Board Examination administered by EEACAB. This examination assesses your understanding of church doctrine, leadership principles, and pastoral responsibilities. Meeting all these requirements is crucial for achieving the role of Bishop within the Church.

BIBL-ABL105-3 - Old Testament Survey I: This course provides a chronological survey of Old Testament historical, geographical, literary, and basic message of the Old Testament books.

BIBL-ABL106-3 - Old Testament Survey II: This course is the continuation of Old Testament survey covering the historical, geographical, literary, and basic message of the Old Testament books.

LEAD-ABL107-3 - Leadership of Christ: This course examines the life and teachings of Jesus Christ as a model for leadership, analyzing biblical examples of his actions, character traits, and teachings to extract key principles applicable to modern leadership roles, with a focus on servant leadership, compassion, and ethical decision-making within a Christian context.

BUSN-ABL108-3 - **Organizational Management:** This course will explore the core functions of planning, organizing, leading, and controlling within an organization, focusing on developing skills to effectively manage resources, teams, and processes to achieve organizational goals, including topics like decision-making, communication, leadership styles, organizational structure, ethical considerations, and managing change within a business environment.

LEAD-ABL006-3 - Kingdom Leadership Introduction: This course is designed to give a better understanding of global leadership from a biblical perspective.

LEAD-ABL201-3 - **Principles of Leadership:** This course will provide an introduction to the foundational concepts of leadership, exploring various leadership theories, styles, and skills, enabling students to examine their own leadership philosophy and develop the ability to apply effective leadership practices in different organizational settings, including building teams, managing conflict, and creating a positive work culture; often incorporating case studies, simulations, and self-reflection exercises to practice these principles in real-world scenarios.

LEAD-ABL204-3 - The Art of Youth Leadership: This course aims to equip students with the skills and knowledge necessary to lead youth into discovering their leadership potential. Emphasis will be placed on how to assist youth to focus on developing their personal leadership qualities, communication abilities, critical thinking, teamwork, conflict resolution, and project management skills, and community engagement opportunities.

LEAD-ABL206-3 - **Leadership Coach:** This course is designed to teach various coaching methods that effectively enhance and expand a person's leadership skills and abilities. Participants will engage in powerful questioning techniques that provoke thought and encourage self-reflection. Through guided exercises, students will explore their personal leadership challenges in a supportive environment, allowing them to develop deeper insights into their behaviors and decision-making processes. The course emphasizes the importance of creating dedicated time and space for participants to work through these leadership issues, fostering an environment where they can thoughtfully examine their experiences and develop actionable strategies for improvement. By the end of the course, students will have a richer understanding of their leadership styles and how to apply these skills in real-world scenarios.

BIBL-ABL207-3 - **Nehemiah:** This course will analyze the narrative of Nehemiah giving a better understanding of its leadership style and principles, prayer, as well as the books spirituality and practicality.

ELECTIVES: 6

BACHELOR OF ARTS CHRISTIAN LEADERSHIP

BIBL-BCL200-3 - The Wisdom Books: This course deals with the Poetic and Wisdom Literature of the Old Testament, with particular emphasis on the Book of Psalms.

BIBL-BCL201-3 - Pastoral Epistles: This course examines the letters of Paul to Timothy, Titus, and Philemon, and focuses on how the letters apply to church leadership and ministry and how they functioned in the church context to which they were written.

PHIL-BCL202-3 - **Ethics:** This course will address the principles and problems of ethical decision making. This will include a survey of the history and variety of approaches to ethics. Biblical principles will be sought and emphasis placed on the application of these principles to contemporary ethical issues.

PHIL-BCL207-3 - Conflict Management and Resolution: This course provides students with the knowledge and skills to effectively identify, understand, and navigate conflicts in personal, professional, and organizational settings, equipping them with strategies to resolve disputes constructively through communication, negotiation, and mediation techniques, aiming to minimize negative impacts and foster positive outcomes.

LEAD-BCL208-3 - Principles of Leadership II: This course probes deeper into advanced leadership theories, concepts, and practical applications, focusing on developing the skills needed to effectively lead teams in complex situations, often including topics like situational leadership, conflict resolution, change management, ethical decision-making, and motivating diverse groups.

LEAD-BCL206-3 - Servant Leader: This course will introduce the basic elements comprising the philosophy of servant leadership, along with the core values of citizenship, excellence, continuous learning and integrity.

MGMT-BCL203-3 - **Church Administration:** This course provides an overview of church administration and management of nonprofit organizations.

HIST-BCL204-3 - **Church History:** This course provides a general survey of the history of the Christian church from its founding at Pentecost to the present day, emphasizing the cultural, political, social and religious factors which influenced the Church's journey, and how significant men and women emerged to support and challenge the Church's understanding of itself and its relationship with the world.

BIBL-BCL209-3 - **Hermeneutics**: This course examines the principles and practices of biblical interpretation, as well as the primary tools for biblical research. Students will become acquainted with the history of interpretation and a defense of the literal-historical-grammatical approach. Hermeneutical strategies will be used to interpret various literary genres, examine historical and literary contexts, analyze structural relationships, perform word studies, and develop principles for practical application.

COMM-BCL-210-3 - **Public Speaking**: This course probes deeper into the principles of effective oral communication. The goal is to help students become more confident and comfortable speaking in front of others. The course covers topics like speech writing, presentation skills, and audience engagement, and provides instruction and experience in preparation and delivery of speeches within a public setting and group discussion. Emphasis is placed on research, preparation, delivery, and evaluation of informative, persuasive, and special occasion public speaking.

LEAD-BCL-211-3 - Pastoral Leadership: This course is designed to provide a thorough, biblically-based approach to practical ministry leadership. This program emphasizes sound doctrine and the ability to exposit biblical Scriptures from an accurate, conservative, evangelical hermeneutic principle.

LEAD-BCL-212-3 - Kingdom Leadership: This course is designed to give a better understanding of global leadership from a biblical perspective.

HLTH-BCL-213-3 - **Health and Wellness:** This course introduces the concept of holistic health, exploring various aspects of physical, mental, and social well-being, focusing on lifestyle choices, nutrition, exercise, stress management, disease prevention, and personal responsibility to maintain a healthy lifestyle; including topics like substance abuse, sexual health, and environmental factors that impact health.

BIBL-BCL-214-3 - **New Testament Survey:** This course provides an overview of the historical, geographical, literary, religious and political context in which the New Testament documents were written.

BUSN-BCL205-3 - Strategic Planning: This course provides a comprehensive understanding of the process of developing and implementing long-term goals for an organization, including analyzing the internal and external environment, identifying strategic options, setting clear objectives, allocating resources, and monitoring progress, equipping students with the skills to make informed strategic decisions and guide an organization towards future success.

BACHELOR OF ARTS BIBLICAL LEADERSHIP

BIBL-BBL200-3 - Synoptic Gospels: This course will examine the New Testament Gospels of Matthew, Mark and Luke, with special focus on the distinctive portrait of Jesus that each present. Emphasis will be placed on Christology, with a general introduction to literary, socio-historical and tradition-critical methodologies.

BIBL-BBL201-3 - Pastoral Epistles: This course examines the letters of Paul to Timothy, Titus, and Philemon, and focuses on how the letters apply to church leadership and ministry and how they functioned in the church context to which they were written.

PHIL-BBL202-3 - Ethics II: This course will address the principles and problems of ethical decision making. This will include a survey of the history and variety of approaches to ethics. Biblical principles will be sought and emphasis placed on the application of these principles to contemporary ethical issues.

MIN-BBL207-3 - Conflict Management and Resolution: This course will explore the practical application of conflict resolution strategies within a religious setting, equipping students with the skills to effectively navigate disagreements and disputes among church members, leaders, and staff, while upholding biblical principles and maintaining a healthy congregational environment; focusing on techniques like active listening, mediation, communication skills, and ethical decision-making in challenging situations within the ministry context.

LEAD- BBL208-3 - Principles of Leadership II: This course probes deeper into advanced leadership theories, concepts, and practical applications, focusing on developing the skills needed to effectively lead teams in complex situations, often including topics like situational leadership, conflict resolution, change management, ethical decision-making, and motivating diverse groups.

LEAD-BBL206-3 - Transformation Leadership: This course is designed to engage students in understanding, implementing, and evaluating strategic leadership practices based on various theories, models, and approaches for achieving organizational transformation.

THEO-BBL203-3 - Systematic Theology I: This course is designed to give a concise introduction to the nature, history and methodology of systematic theology.

COMM-BBL204-3 - **Homiletics:** This course is an introduction to theories and practices of preaching in pastoral and liturgical settings.

BIBL-BBL209-3 - **Hermeneutics:** This course examines the principles and practices of biblical interpretation, as well as the primary tools for biblical research. Students will become acquainted with the history of interpretation and a defense of the literal-historical-grammatical approach. Hermeneutical strategies will be used to interpret various literary genres, examine historical and literary contexts, analyze structural relationships, perform word studies, and develop principles for practical application.

BIBL-BBL210-3 - Bibliology: This course is centered on understanding the authority and nature of the Scriptures.

LEAD-BBL211-3 - Pastoral Leadership: This course is designed to provide a thorough, biblically-based approach to practical ministry leadership. This program emphasizes sound doctrine and the ability to exposit biblical Scriptures from an accurate, conservative, evangelical hermeneutic principle.

BIBL-BBL212-3 - The Six Foundational Doctrines: This course will provide an exploration of the six foundational teachings outlined in Hebrews Chapter 6. Participants will explore the principles of Repentance, examining its significance in the spiritual journey; Faith toward God, emphasizing the importance of trust in the divine; and Baptism, discussing its role as a vital rite of initiation. The course will also cover the Laying on of Hands, a practice rich in meaning and healing; the concept of Resurrection, which offers hope and renewal; and finally, Eternal Judgment, exploring the implications of moral accountability and the life to come.

BIBL-BBL213-3 - Old Testament Survey II: This course is the continuation of Old Testament survey covering the historical, geographical, literary, and basic message of the Old Testament books.

BIBL-BBL214-3 - **New Testament Survey II:** This course is the continuation of New Testament survey covering the historical, geographical, literary, religious and political context in which the New Testament documents were written.

BUSN-BBL205-3 - Strategic Planning: This course provides a comprehensive understanding of the process of developing and implementing long-term goals for an organization, including analyzing the internal and external environment, identifying strategic options, setting clear objectives, allocating resources, and monitoring progress, equipping students with the skills to make informed strategic decisions and guide an organization towards future success.

BACHELOR OF ARTS CHRISTIAN COUNSELING AND MINISTRY

BIBL-BCM200-3 - Understanding Prayer: This course is designed to help students understand the meaning and purpose of prayer and how to effectively engage in it. The course aims to deepen the student's knowledge and practice of prayer by exploring the biblical foundation of prayer, different types of prayer (like praise, petition, intercession), how to approach God in prayer, and practical strategies for developing a consistent prayer life, with a focus on personal reflection and application to daily life.

BIBL-BCM201-3 - **Pastoral Epistles:** This course examines the letters of Paul to Timothy, Titus, and Philemon, and focuses on how the letters apply to church leadership and ministry and how they functioned in the church context to which they were written.

PHIL-BCM202-3 - Ethics II: This course will address the principles and problems of ethical decision making. This will include a survey of the history and variety of approaches to ethics. Biblical principles will be sought and emphasis placed on the application of these principles to contemporary ethical issues.

MIN-BCM207-3 - Conflict Management and Resolution: This course will explore the practical application of conflict resolution strategies within a religious setting, equipping students with the skills to effectively navigate disagreements and disputes among church members, leaders, and staff, while upholding biblical principles and maintaining a healthy congregational environment; focusing on techniques like active listening, mediation, communication skills, and ethical decision-making in challenging situations within the ministry context.

MIN-BCM208-3 - Dealing with Anger: This course is designed to teach individuals how to identify the root causes of anger, understanding their triggers, and developing effective strategies to manage and express anger in healthy ways, often including techniques like deep breathing, cognitive restructuring, and assertive communication skills to navigate challenging situations without resorting to destructive behaviors.

THEO-BCM206-3 - Theology of Christian Counseling: This course is designed to provide a biblical and theological framework for the work of the Christian counselor. The course integrates theological truth and psychological principles by exploring such topics as epistemology, empowerment, and whole-person healing.

COUN-BCM203-3 - **The Five Counseling Theories**: This course will cover a comprehensive examination of the core principles, applications, and origins of five major theoretical frameworks in counseling, often including: Psychoanalytic, Cognitive Behavioral, Humanistic, Existential, and Adlerian therapies; allowing students to critically analyze each theory, understand their strengths and limitations, and develop a personal theoretical approach to client intervention based on their individual needs and situations.

PSY-BCM204-3 - **Psychotherapy Approaches**: This course will explore various theoretical models used in psychotherapy, including key assumptions, therapeutic techniques, the role of the therapist, and how each approach can be applied to different client populations, with a focus on understanding the strengths and limitations of each method while considering cultural competency and evidence-based practices.

COUN-BCM210-3 - Suicide and Grief Counseling: This course provides comprehensive training on understanding and supporting individuals experiencing complex grief following the suicide of a loved one, encompassing the unique dynamics of suicide bereavement, appropriate intervention strategies, and how to navigate the intense emotions associated with such loss, while equipping counselors with the necessary skills to assess suicide risk and provide sensitive, effective therapeutic support.

COUN-BCM211-3 - Building Strong Marriages and Families: This course is designed to provide students the opportunity to learn about the research, theory, principles, and applications that produce successful marriages, how to share marital principles in both religious and non-religious settings, how to find and synthesize marital research, assess marital functioning, establish and maintain a healthy marriage in a challenging environment, and practice living important principles pertaining to successful relationships.

BIBL-BCM212-3 - Living Epistles: This course examines the New Testament epistles (letters) from the Bible, emphasizing how the teachings and principles within them can be applied to contemporary Christian life, essentially viewing believers as "living letters" where God's message is actively demonstrated through their actions and character. The course explores the practical implications of the epistles, encouraging personal transformation and living out the Christian faith in daily life.

BIBL-BCM213-3 - **Old Testament Survey:** This course provides a chronological survey of Old Testament historical, geographical, literary, and basic message of the Old Testament books.

BIBL-BCM214-3 - **New Testament Survey:** This course provides an overview of the historical, geographical, literary, religious and political context in which the New Testament documents were written.

MHAT-BCM205-3 - Mental Health Awareness: This course aims to educate individuals about common mental health conditions, their symptoms, potential risk factors, and how to appropriately respond to someone experiencing mental health challenges, while also working to reduce stigma associated with mental illness by promoting understanding and empathetic communication strategies.

MASTER OF ARTS CHRISTIAN LEADERSHIP

LEAD-MCL400-3 - King David Leadership: This course explores the leadership qualities exhibited by the biblical figure King David, exploring his strengths like courage, integrity, humility, and reliance on God, while also examining his failures to understand the importance of accountability and repentance, all with the aim of applying these lessons to modern leadership situations in personal and professional life.

LEAD-MCL401 - The Rise and Fall of Kingdom Empires: This course explores the historical development and eventual decline of major empires throughout history, examining the political, social, economic, and military factors that contributed to their rise to power, as well as the internal and external forces that led to their eventual collapse; comparing and contrasting different empires across various time periods and regions to identify common patterns and unique characteristics.

BIBL-MCL408-3 - Old Testament Prophets: This course examines the prophetic books of the Bible, including their historical context, literary genres, and theological significance. The course also explores the prophets' messages and methods, and how they relate to the social, religious, and political dynamics of ancient Israel.

MIN-MCL403-3 - Ministerial Ethics & Protocol: This course examines the moral standards and appropriate behaviors expected of religious leaders; exploring biblical principles, ethical decision-making in various ministry situations, proper conduct within the church community, and the appropriate protocols for interacting with members and other religious leaders, all aimed at maintaining a high level of integrity and professionalism in ministry.

LEAD-MCL404-3 - **Leading and Building like Nehemiah:** This course explores the leadership principles exemplified by the biblical figure Nehemiah, focusing on his strategies for mobilizing people, overcoming obstacles, and achieving significant goals, particularly through a strong work ethic, servant leadership, and reliance on prayer, to build and restore communities, with practical applications for modern leadership roles across various contexts.

BIBL-MCL409-4 - Biblical Covenants: This course examines the agreements between God and humanity in the Bible such as the Adamic, Abrahamic, Noahic, Mosaic and Davidic covenants. The course explores the covenants' significance, how they relate to the Bible's narrative, and their application to Christian life.

BIBL-MCL406-3 - Book of Acts: This course reviews the historical, literary, and theological aspects of the Book of Acts. The course will study Acts from the perspective Christian experience, exploring ways that the message of the biblical texts and the experience of the first Christians speak to the life of faith and the mission of the Church today.

MGMT-MCL407-3 - Community Engagement: This course focuses on the student developing skills and knowledge to actively participate in and contribute to community issues that often involve collaboration with local organizations and applying theoretical concepts to real-world situations.

EDCU-MCLT00-20 - **Thesis Leadership Project:** This project centers on a comprehensive examination and application of leadership theories and practices through a significant project. This opportunity enables students to research, analyze, and implement effective leadership strategies aimed at achieving a specific objective. The process typically concludes with a written thesis that showcases their understanding and practical leadership abilities.

MASTER OF ARTS BIBLICAL LEADERSHIP

PHIL-MBL400-3 - Apologetic and Evangelism: This course examines models of apologetics found in Scripture and throughout church history in order to make application of them to contemporary challenges to the Christian faith.

MIN-MBL401-3 - Dynamics of Kingdom Leadership: This course is designed to give a better understanding of global leadership from a biblical perspective.

PHIL-MBL408-3 - **The Apostolic and Prophetic Culture Dynamic:** This course explores the foundational principles, roles, and functions of the apostolic and prophetic dimensions within the Body of Christ. The course explores biblical teaches, historical examples and practical applications to understand the synergy between the apostolic ad prophetic offices, and examines how these dynamics shape spiritual culture, foster kingdom advancement, and build unified, impactful communities of faith.

PHIL-MBL403-3 - Ministerial Ethics & Protocol: This course examines the moral standards and appropriate behaviors expected of religious leaders; exploring biblical principles, ethical decision-making in various ministry situations, proper conduct within the church community, and the appropriate protocols for interacting with members and other religious leaders, all aimed at maintaining a high level of integrity and professionalism in ministry.

BIBL-MBL404-3 - **Minor and Major Prophets:** This course examines the rich tapestry of biblical prophecy, exploring the lives, messages, and historical contexts of both the minor and major prophets of the Old Testament. Students will engage with texts from prophets such as Isaiah, Jeremiah, Ezekiel, and Daniel, as well as the twelve minor prophets, including Hosea, Amos, and Micah. This course aims to provide a comprehensive understanding of the prophetic tradition, examining themes of justice, repentance, hope, and divine intervention.

BIBL-MBL409-4 - **Biblical Covenants:** This course examines the agreements between God and humanity in the Bible such as the Adamic, Abrahamic, Noahic, Mosaic and Davidic covenants. The course explores the covenants' significance, how they relate to the Bible's narrative, and their application to Christian life.

LEAD-MBL406-3 - Book of Esther: This course explores the captivating biblical narrative, focusing on its historical, cultural, and theological significance, allowing the student to gain a deeper understanding of the complexities and enduring relevance of the Book of Esther in both religious and literary contexts. The course examines key themes such as divine providence, identity, and courage, while also considering the historical context of the Persian Empire.

MGMT-MBL407-3 - Community Engagement: This course focuses on the theory and practice of building relationships and collaborating with community members to address local issues, often involving hands-on experiences with community organizations, where students learn how to identify community needs, design impactful projects, facilitate dialogue, and evaluate the effectiveness of engagement strategies, all while developing skills in leadership, communication, and social change advocacy.

LEAD-MBLT00-20 - **Thesis Leadership Project:** This project centers on a comprehensive examination and application of leadership theories and practices through a significant project. This opportunity enables students to research, analyze, and implement effective leadership strategies aimed at achieving a specific objective. The process typically concludes with a written thesis that showcases their understanding and practical leadership abilities.

MASTER OF ARTS CHRISTIAN COUNSELING AND PASTORAL CARE

BIBL-MCP410-3 - **Biblical Counseling I:** This course is an introduction to the principles of counseling using the Bible. The course covers topics such as how to identify problems, how to counsel people, and how to apply Scripture to specific situations.

BIBL-MCP411-3 - Biblical Counseling II: This course teaches students how to apply the Bible to help people with their spiritual struggles. The course covers topics such as marriage counseling, counseling methodologies, and how to apply the Bible to specific problems.

PSY-MCP412-3 - **Psychological Theories II:** This course examines major psychological theories, exploring their applications, critiques, and empirical evidence across various areas of human behavior, focusing on more complex concepts and research methodologies, while building upon the foundational knowledge gained in a "Psychological Theories I" class; students will critically analyze different theoretical perspectives and their relevance to understanding human thought, emotion, and behavior in diverse contexts.

PSY-MCP413-3 - **Psychological Theories III:** This course provides an advanced exploration of major psychological theories, focusing on in-depth analysis of complex concepts, research methodologies, and applications within specific areas of psychology, requiring a prior understanding of foundational psychological principles, and usually covering topics like personality theories, cognitive psychology, social psychology, developmental psychology, and psychopathology at a more nuanced level.

THEO-MCP414-3 - Addictive Behaviors: This course provides a comprehensive examination of various addictive behaviors, including substance use and non-substance related compulsions like gambling or overeating, exploring their psychological mechanisms, assessment methods, treatment approaches, and the impact on individuals and society; drawing from theories in psychology and related fields to understand the complexities of addiction and its management.

COUN-MCP415-4 - Supervised Counseling Practicum I: This course provides a foundational, hands-on experience where students apply theoretical knowledge by conducting individual counseling sessions under close supervision from a licensed professional, focusing on developing core counseling skills like client intake, establishing rapport, active listening, and ethical decision-making within a diverse range of client populations.

COUN-MCP416-4 - Supervised Counseling Practicum II: This course is a continuation of practical, hands-on experience in providing counseling services under the close supervision of a licensed professional, building upon the foundational skills learned in Practicum I, with a focus on advanced case management, complex client presentations, and further development of therapeutic interventions and ethical decision-making within a clinical setting.

COUN-MCP417-3 - Marriage & Family Counseling: This course covers a range of topics, including family and individual development, ethical and legal issues, and clinical research methods. Students learn how to apply these concepts to help families and couples achieve their goals.

BIBL-MCP418-3 - **Pastoral Epistles:** This course examines the letters of Paul to Timothy, Titus, and Philemon, and focuses on how the letters apply to church leadership and ministry and how they functioned in the church context to which they were written.

BIBL-MCP419-3 - Proverbs: This course explores the Book of Proverbs, a cornerstone of biblical wisdom literature. Students will engage with its timeless teachings on practical living, moral decision-making, and spiritual growth. Emphasizing the themes of wisdom, integrity, humility, and the fear of the Lord, this course reveals how Proverbs provides guidance for navigating life's complexities in both ancient and modern contexts.

EDCU-MCPT00-13 - **Thesis Project:** This project centers on a focused research study where students delve deeply into a specific topic related to providing spiritual and emotional support within a Christian context, drawing upon biblical principles, theological frameworks, and psychological theories to analyze a problem, propose solutions, and contribute new knowledge to the field of pastoral care and counseling.

DOCTOR OF CHRISTIAN LEADERSHIP

LEAD-DCL630-3 - **Rise and Fall of Christian Leaders:** This course examines the historical, theological, and sociocultural factors influencing the emergence, development, and decline of Christian leadership throughout history. From the early church fathers to modern-day leaders, students will explore the complex dynamics of power, faith, and influence within Christian traditions.

MIN-DCL631-3 - **Church Administration:** This course provides an overview of church administration and management of nonprofit organizations.

BUSN-DCL632-4 - **Organization Leadership and Budgeting:** This course will examine the governmental structure and officers of a local church, the discipline of the membership, the responsibility of a church in society, and various movements within the church organizations. The course will explore the principles of effective leadership within an organization, with a specific focus on how to strategically manage and utilize the organization's budget to achieve its goals, including understanding financial reporting, budgeting techniques, and aligning financial planning with overall organizational strategy.

MGMT DCL633-3 - Managerial Leadership: This course explores the essential characteristics and functions of successful leadership and management strategies within diverse organizational, community, and cultural frameworks.

BIBL-DCL634-3 - **The Book of Proverbs:** This course explores the Book of Proverbs, a cornerstone of biblical wisdom literature. MIN-DCL635-3 - Understanding the Anointing and Spiritual Gifts: This course provides a comprehensive study of the anointing of God and the operation of spiritual gifts as revealed in Scripture. Students will explore the biblical foundation, purpose, and manifestation of spiritual gifts, along with the role of the anointing in empowering believers for ministry and daily living.

HLTH-DCL636-3 - **Leadership Mental Health Aid:** This course equips current and aspiring Christian leaders with the knowledge and tools to address mental health challenges within their communities. Combining biblical principles with psychological insights, students will explore the intersection of faith, mental health, and leadership.

BIBL-DCL637-3 - The Book of Jude: This course examines the Book of Jude, one of the shortest yet most powerful epistles in the New Testament. Students will explore its urgent call to defend the faith, its warnings against false teachers, and its emphasis on living a life grounded in God's truth and love.

LEAD-DCL638-3 - Leadership Theories: This course explores theoretical models and frameworks associated with leadership. It investigates how individuals emerge as leaders, identifies the traits of effective leaders, and examines how to implement different leadership styles across diverse organizational settings. The course emphasizes the practical implications of these theories in real-life scenarios, often featuring discussions on ethical leadership and encouraging self-reflection regarding personal leadership strengths and weaknesses.

LEAD-DCL639-3 - Leading with a Vision: This course examines the role and significance of vision within the Church, the dynamics of developing and defining a vision in leadership, how to successfully cast that vision to a group of people, and keys to sustaining a vision.

BUSN-DCL640-4 - Non-Profit Organizations Policies: This course will explore the legal and ethical framework that guides the operations of non-profit organizations. It will address essential topics such as board governance, financial management, fundraising practices, conflict of interest policies, compliance regulations, and ethical decision-making tailored to the non-profit sector. This course will equip students with the knowledge necessary to create and implement strong policies for effective management in the non-profit arena.

EDUC-DCLD-1 - **Dissertation Project:** This project centers on the development and execution of an independent and extensive research project, culminating in a substantial written document that demonstrates mastery of the student's field of study, including selecting a relevant topic, conducting thorough literature review, utilizing appropriate research methodologies, analyzing data, interpreting findings, and effectively communicating results.

DOCTOR OF THEOLOGY

BIBL-THD600-2 - Biblical Covenants: This course examines the agreements between God and humanity in the Bible such as the Adamic, Abrahamic, Noahic, Mosaic and Davidic covenants. The course explores the covenants' significance, how they relate to the Bible's narrative, and their application to Christian life.

BIBL-THD601-3 - Old Testament Survey: This course provides a chronological survey of Old Testament historical, geographical, literary, and basic message of the Old Testament books.

BIBL-THD602-3 - New Testament Survey: This course provides an overview of the historical, geographical, literary, religious and political context in which the New Testament documents were written.

BIBL-THD603-3 - **Hermeneutics:** This course examines the principles and practices of biblical interpretation, as well as the primary tools for biblical research. Students will become acquainted with the history of interpretation and a defense of the literal-historical-grammatical approach. Hermeneutical strategies will be used to interpret various literary genres, examine historical and literary contexts, analyze structural relationships, perform word studies, and develop principles for practical application.

BIBL-THD604-3 - **Bibliology Theology:** This course examines the nature, authority, and sufficiency of the Bible as scripture, focusing on key doctrines like inspiration, inerrancy, canonicity, and the development of the biblical canon throughout history, essentially exploring how Christians should understand and interpret the Bible as God's revealed word, which may include discussions on different views regarding biblical interpretation and their implications for theological understanding.

THEO-THD605-3 - Systematic Theology I: This course introduces the doctrines of God, humanity, and God's Word. It emphasizes the scriptural basis for each doctrine and uses a contemporary approach.

THEO-THD606-3 - Systematic Theology II: This course probes deeper into key Christian doctrines, including the person and work of Jesus Christ, the Holy Spirit, salvation, the church, and the end times, building upon foundational theological concepts covered in a "Systematic Theology I" course, and exploring complex issues related to the nature and extent of salvation, the origin and future of the church, and the eternal state.

THEO-THD607-3 - Systematic Theology III: This course focuses on a deeper exploration of key Christian doctrines, including the nature of sin (hamartiology), the doctrine of salvation (soteriology), the understanding of the Church (ecclesiology), and the study of the end times (eschatology), and building upon foundational theological concepts covered in previous Systematic Theology courses, with a critical analysis of different theological perspectives on these topics within a specific Christian tradition.

THEO-THD608-3 - Foundational Doctrines: This course is an introductory study of the core beliefs and principles of a particular faith. The course focuses on key biblical doctrines like the nature of God, the person of Jesus Christ, salvation, the Holy Spirit, and the Church, providing a comprehensive understanding of the foundational tenets that shape the faith and its practice; essentially, it aims to equip students with a solid base of theological knowledge to further explore more complex theological topics.

BIBL-THD609-3 - Christian Apologetics: This course examines barriers to Christian faith as well as efforts to provide convincing presentations of Christian faith. Attention is given to biblical foundations, historical development, apologetic method, and contemporary issues related to apologetics. The course covers the theological and historical foundations of Christian faith, how to respond to challenges to that faith, and how to engage with cultural issues and skepticism from an apologetic perspective.

SOC-THD610-3 - **Denominations in the US:** This course covers the history of Christian denominations, the relationship between the Church and American culture, or the diversity of religious groups in the United States.

RELS-THD611-3 - World Religion and Western Culture: This course explores the major religious traditions considered part of Western culture, primarily Judaism, Christianity, and Islam, examining their historical development, core beliefs, practices, and how they have shaped the social, political, and artistic landscape of the West, while also comparing and contrasting them with other global religious traditions and analyzing their influence on Western culture as a whole.

THEO-THD612-3 - The Making of a Theologian: This course is designed to introduce students to the foundational principles, historical development, and critical methods of theological study, equipping them to engage with complex theological questions by examining the lives and works of significant theologians throughout history, while exploring the process of constructing and interpreting theological doctrines within their respective contexts, fostering a personal theological reflection and understanding of their own faith tradition.

THEO-THDD-18 - Dissertation Project: This project centers on a guided, in-depth research project where students select a theological topic, formulate a focused research question, critically analyze relevant primary and secondary sources, and produce a substantial written document defending a well-argued thesis. The project allows the student to probe deeply into a specific area of theological study and demonstrate advanced scholarly skills within their chosen field of study.

DOCTOR OF MINISTRY

BIBL-THD600-2 - Biblical Covenants: This course examines the agreements between God and humanity in the Bible such as the Adamic, Abrahamic, Noahic, Mosaic and Davidic covenants. The course explores the covenants' significance, how they relate to the Bible's narrative, and their application to Christian life.

BIBL-THD601-3 - Understanding the Sacraments: This course provides a comprehensive study of the sacraments, examining their biblical foundations, theological significance, and role in the life of the church. Students will explore how sacraments such as baptism and the Lord's Supper serve as visible signs of God's grace, expressions of faith, and means of spiritual nourishment for believers.

BIBL-THD602-3 - Book of Acts: This course reviews the historical, literary, and theological aspects of the Book of Acts. The course will study Acts from the perspective Christian experience, exploring ways that the message of the biblical texts and the experience of the first Christians speak to the life of faith and the mission of the Church today

BIBL-THD603-3 - **Hermeneutics:** This course examines the principles and practices of biblical interpretation, as well as the primary tools for biblical research. Students will become acquainted with the history of interpretation and a defense of the literal-historical-grammatical approach. Hermeneutical strategies will be used to interpret various literary genres, examine historical and literary contexts, analyze structural relationships, perform word studies, and develop principles for practical application.

HLTH-THD605-3 - **Leadership Mental Health Aid:** This course equips current and aspiring Christian leaders with the knowledge and tools to address mental health challenges within their communities. Combining biblical principles with psychological insights, students will explore the intersection of faith, mental health, and leadership.

EDUC-THD606-3 - Christian Education System: This course explores the principles, practices, and purpose of the Christian education system. Students will examine its historical development, biblical foundations, and the distinctive values that shape faith-based teaching and learning.

MIN-THD607-3 - Understanding the Anointing and Spiritual Gifts: This course explores the biblical idea of the Holy Spirit's anointing and how it empowers believers to effectively use their God-given spiritual gifts in both ministry and daily life. This includes identifying various types of gifts, comprehending their appropriate applications, and learning to discern and nurture the Holy Spirit's presence within oneself to authentically operate in these gifts. The course is structured to offer students a thorough understanding of both the biblical and practical dimensions of spiritual empowerment and the diverse gifts granted by the Holy Spirit.

MIN-THD608-3 - Ministry Leadership: This course is designed for students aspiring to leadership roles within a religious community, focusing on developing the skills necessary to lead effectively through biblical principles, theological understanding, and practical leadership strategies, including areas like spiritual development, congregational care, communication, conflict resolution, and church administration.

PHIL-THD609-3 - Understanding Systems, Cycles, Patterns, and Seasons: This course explores the intricate ways the Bible reflects natural and spiritual systems that govern life and faith. Students will explore how cycles, such as those of creation, redemption, and renewal, manifest throughout biblical narratives, offering insights into God's order and purpose. The course examines patterns in scriptural stories, revealing divine principles and lessons relevant to contemporary life. Additionally, it investigates the concept of seasons, both literal and metaphorical, as depicted in biblical texts, providing a framework for understanding spiritual growth and transformation.

SOC-THD610-3 - **Denominations in the US:** This course covers the history of Christian denominations, the relationship between the Church and American culture, or the diversity of religious groups in the United States

THEO-THD612-3 - The Making of a Theologian: This course is designed to introduce students to the foundational principles, historical development, and critical methods of theological study, equipping them to engage with complex theological questions by examining the lives and works of significant theologians throughout history, while exploring the process of constructing and interpreting theological doctrines within their respective contexts, fostering a personal theological reflection and understanding of their own faith tradition.

EDUC-THDD-18 - Final Project – 501 (C) 3 For Non-Profit Organizations: The project centers on the development and execution a project that gives the student the opportunity to use the knowledge learned in class to practice creating a nonprofit organization to serve the needs of certain populations or solve/alleviate certain social issue(s).
